

Terms and Conditions of Use

Shri Shikshayatan School Website

1. Introduction

1.1. These Terms and Conditions govern your use of the official website of Shri Shikshayatan School (“the School”). By accessing or using our website, you accept these Terms in full. If you disagree with any part of these Terms, you must not use our website.

1.2. If you register, submit any information, or use any service through our website, you will be deemed to have agreed to these Terms.

1.3. Our website uses cookies. By using the website or agreeing to these Terms, you consent to our use of cookies in accordance with our Privacy and Cookies Policy.

2. Licence to Use the Website

2.1. Subject to these Terms, you may:

- (a) View pages on the website through a web browser;
- (b) Download pages for caching;
- (c) Print pages;
- (d) Stream available audio or video content;
- (e) Use the website services as provided.

2.2. Except as permitted above, you must not download, copy, or store any content from the website.

2.3. The website is for personal, educational, and informational use only.

2.4. You must not modify, alter, or edit any part of the website’s content.

2.5. Unless you own or control the relevant rights, you must not:

- (a) Republish website material;
- (b) Sell, rent, or sub-license website content;
- (c) Exploit website content commercially;
- (d) Redistribute website content.

2.6. The School reserves the right to restrict access to certain areas or the entire website.

3. Acceptable Use

3.1. You must not use the website:

- (e) In violation of our robots.txt directives;

3.2. You must not use data obtained from the website to contact individuals or organizations except for the third parties approved by the management.

3.3. All information you provide must be accurate, complete, and not misleading.

4. Registration and Accounts

4.1. Users may register by completing the applicable forms available on the website.

4.2. You must not permit another person to use your account.

4.3. You must immediately notify the School of unauthorised use of your account.

4.4. You must not use another person's account without permission.

5. User Login Details

5.1. If login credentials are provided or chosen, you must ensure they are accurate and not misleading.

5.2. You must keep your password confidential and notify us if it is disclosed.

5.3. You are responsible for all activities on your account arising from your failure to maintain confidentiality.

6. Cancellation and Suspension :

The School may suspend, cancel, or edit user accounts at its discretion without prior notice.

7. User Content: Licence

7.1. "User Content" includes text, images, videos, documents, or any material submitted to the website.

7.2. By submitting content, you grant the School a worldwide, irrevocable, non-exclusive, royalty-free licence to use, store, reproduce, publish, and distribute such content.

7.3. You waive your moral rights to the maximum extent permitted by law.

7.4. You may edit your content using available website tools.

7.5. The School may remove or edit your content if you breach these Terms.

8. User Content: Rules

8.1. You warrant that your content complies with the law and these Terms.

8.2. Content must not be illegal, infringe rights, or give rise to legal liability.

8.3. Content must not be:

- (a) Libellous, false, or malicious;
- (b) Obscene or indecent;
- (c) In violation of intellectual property rights;
- (d) In breach of confidentiality or privacy;
- (e) Negligent, harmful, or dangerous;
- (f) Inciting criminal activity;
- (g) Racist, hateful, or discriminatory;
- (h) Violent, explicit, or pornographic;
- (i) Misleading or fraudulent;
- (j) Offensive or harassing;
- (k) Spam.

9. Limited Warranties

9.1. The School does not warrant:

- (a) Completeness or accuracy of website information;
- (b) That the content is up to date;
- (c) That the website or its services will always be available.

9.2. The School may modify or discontinue website services without notice or liability.

9.3. All warranties and representations are excluded to the maximum extent permitted under law.

10. Breach of Terms

10.1. If you breach these Terms, we may:

- (c) Permanently block access;
- (d) Block your IP address;

- (f) Initiate legal action;
- (g) Delete your account.

10.2. You must not attempt to bypass access restrictions.

11. Variation of Terms

11.1. The School may update or revise these Terms at any time.

11.2. Revised Terms apply from the date of publication on the website.

11.3. If you do not agree to revised Terms, you must stop using the website.

12. Assignment

12.1. The School may transfer or subcontract its rights or obligations under these Terms.
